- Vendors will provide information via completing an online form including their contact information, website URL, description of services, logo and photo for background image. **Caring Organizer** will create a unique Vendor page for each Vendor to be listed in the **Caring Organizer** Local Directory. We prefer to accept files in **high resolution**. Please supply *.jpg or *.png file formats. Any changes to the Vendor Listing must be made in writing by email no later than one month after publication on the website to sales@caringorganizer.com.
- Submitted copy for Vendor Listing Description of Services may be edited for length and voice. Inclusion in the **Caring Organizer** Local Directory is up to the discretion of **Caring Organizer**. Submitting a listing does not guarantee inclusion. Feel free to contact us at sales@caringorganizer.com with questions about your listing or submission.
- Orders and enquiries for Vendor services will be conducted solely between Visitors to the website and the Vendor.
- Vendors registered to be listed in the Caring Organizer Local Directory will receive first three months free. After this period, said Vendors will be charged \$100 per month to credit card provided.
